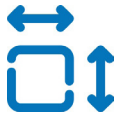

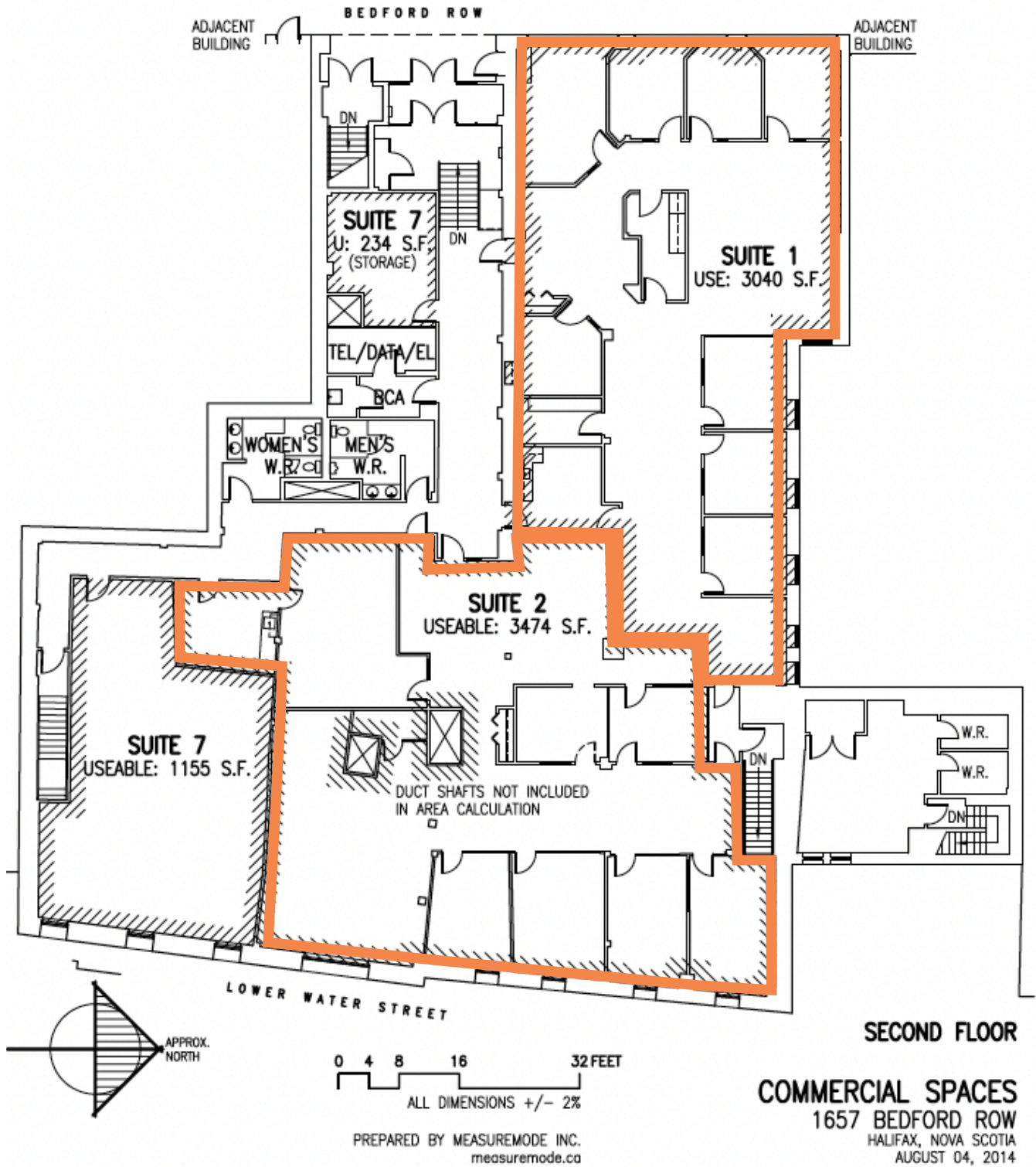

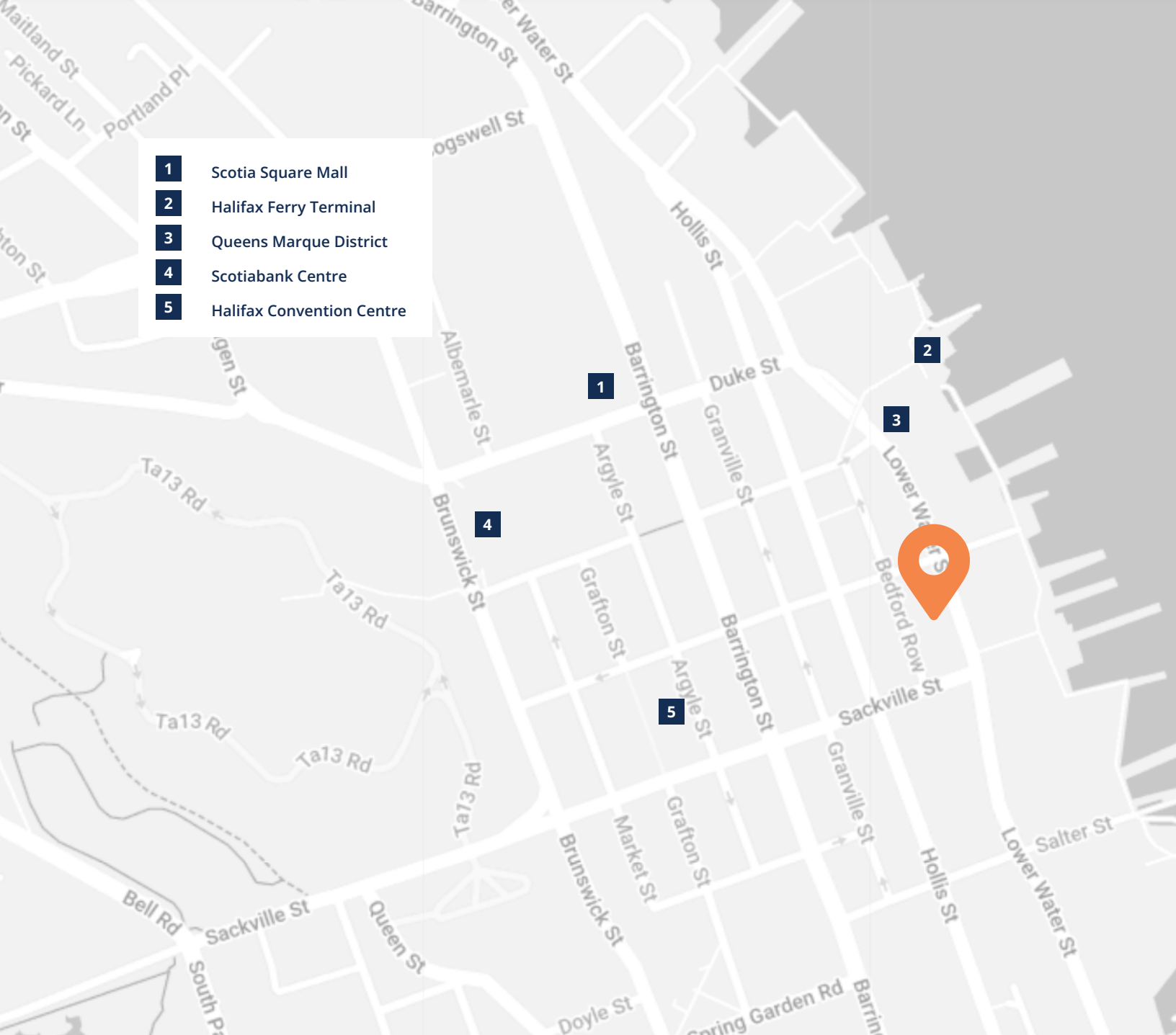


1657 BEDFORD ROW | DOWNTOWN HALIFAX
