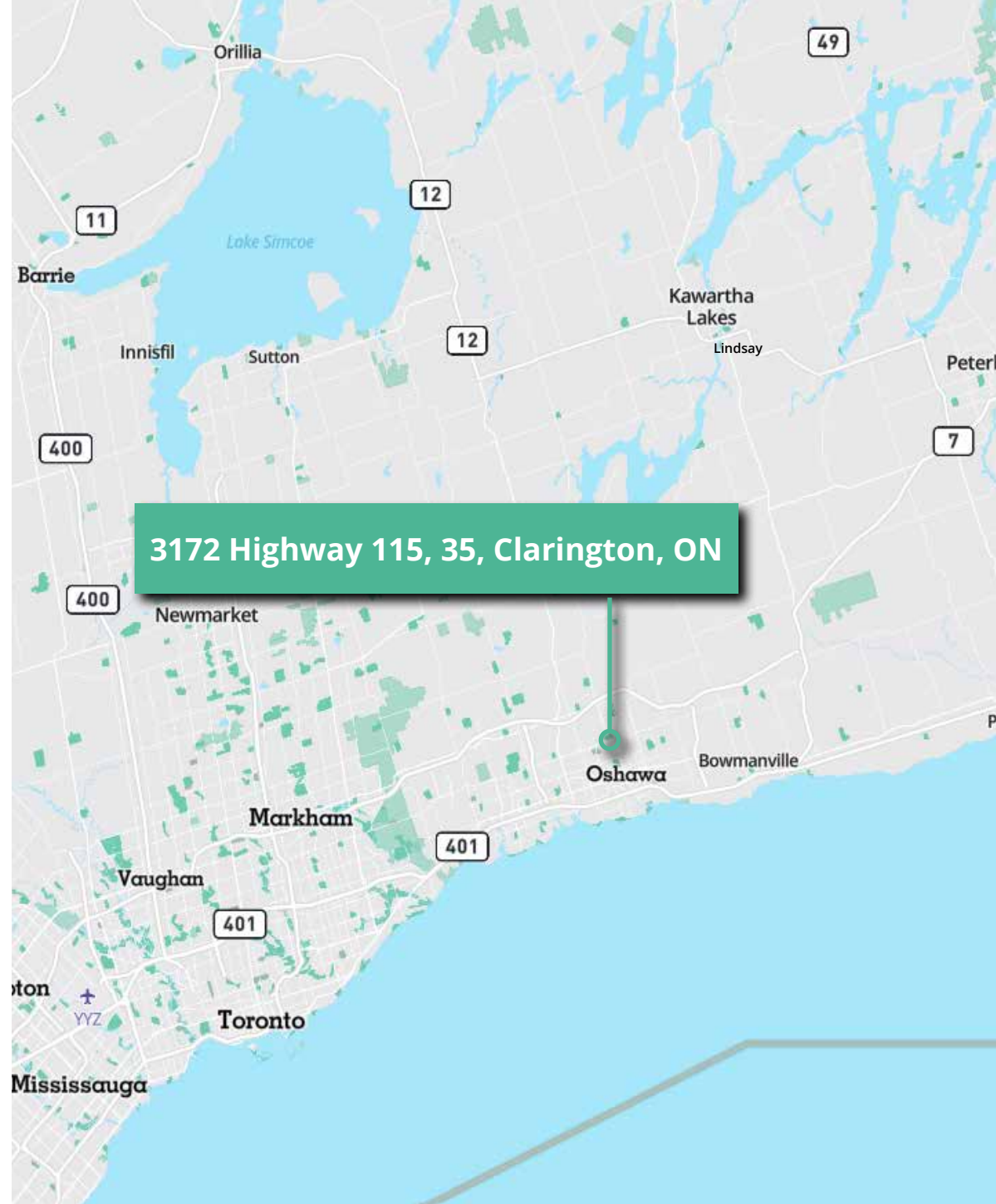
The Opportunity
