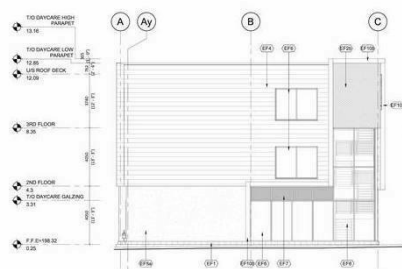
1 SOUTH ELEVATION
