The property offers flexible leasing options from 2,000 SF to 6,000 SF with three demisable bays, 16' clear ceiling height, three (3) 14' x 12' grade level doors, and 600 amp 12/208 volt, 200 amp 3-phase power. Additional features include separate power meters, heat pump and baseboard heating, durable steel siding, and an oversized parking area suitable for large vehicles and industrial users.

Situated within a well-established and growing industrial park in Debert, 216 Lancaster Crescent is surrounded by a strong mix of commercial, transportation, construction, and industrial users. The area is home to a variety of warehousing, manufacturing, trades, and service-based businesses, making it an ideal location for industrial operations. 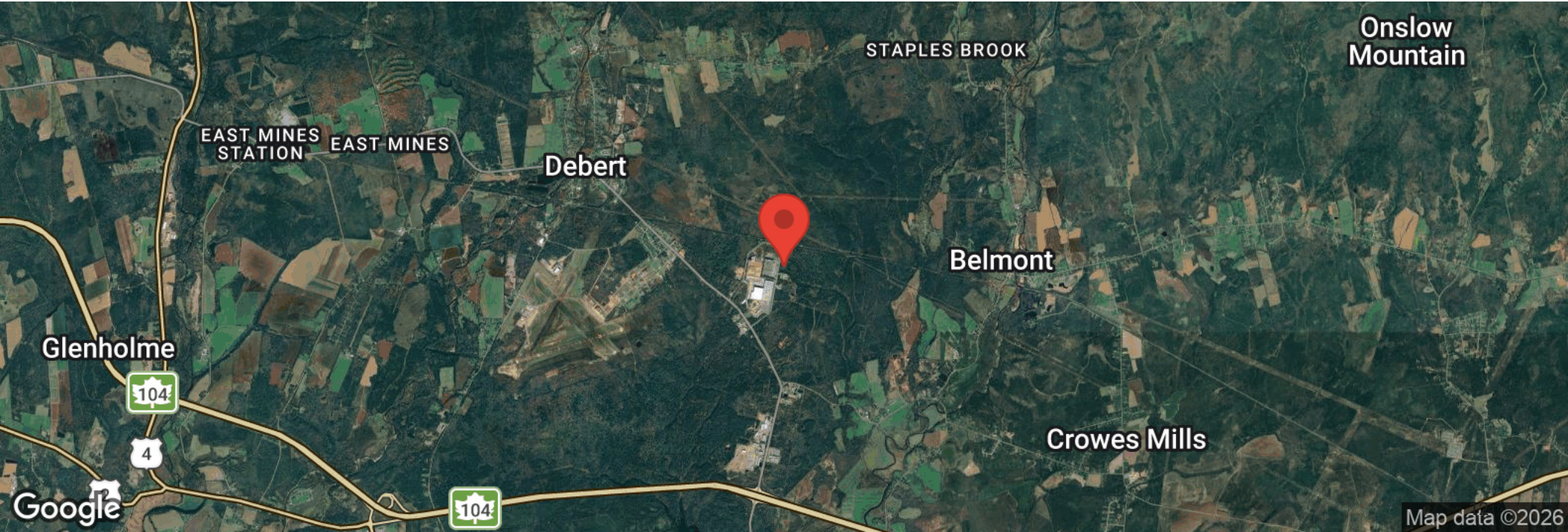
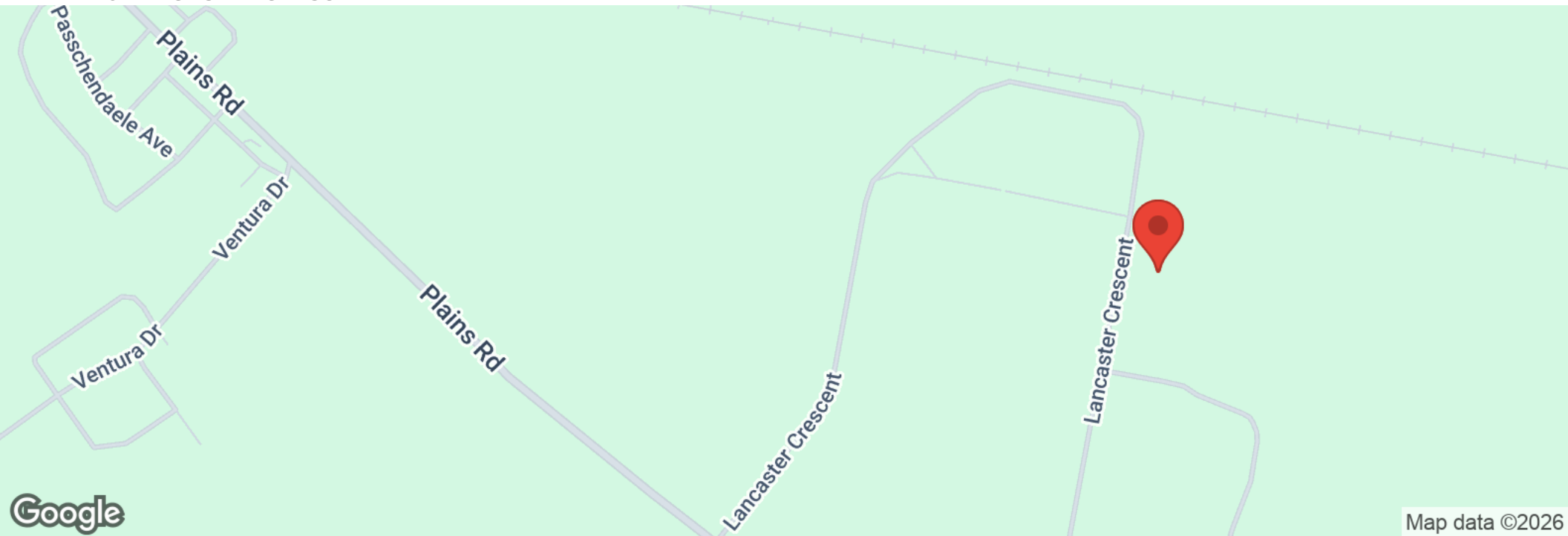
SUBDIVISION PLAN
