### SPACE OVERVIEW

- » Functional Industrial Bay located in Building 1 at the highly sought-after Canal108 development in SE Calgary

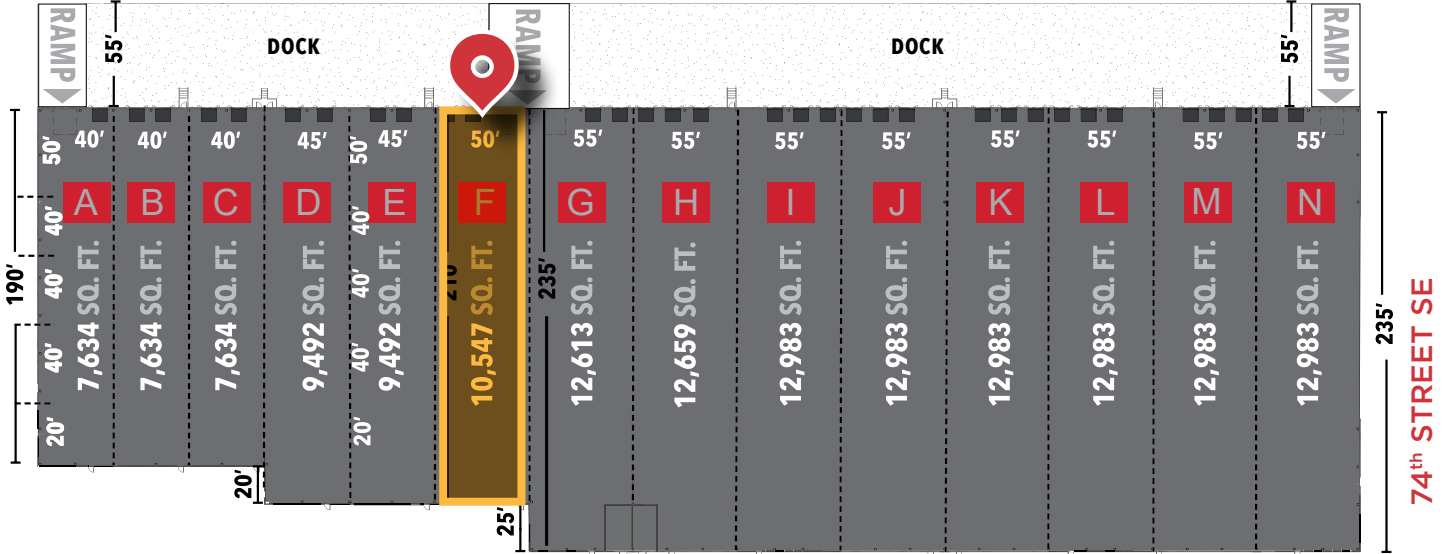

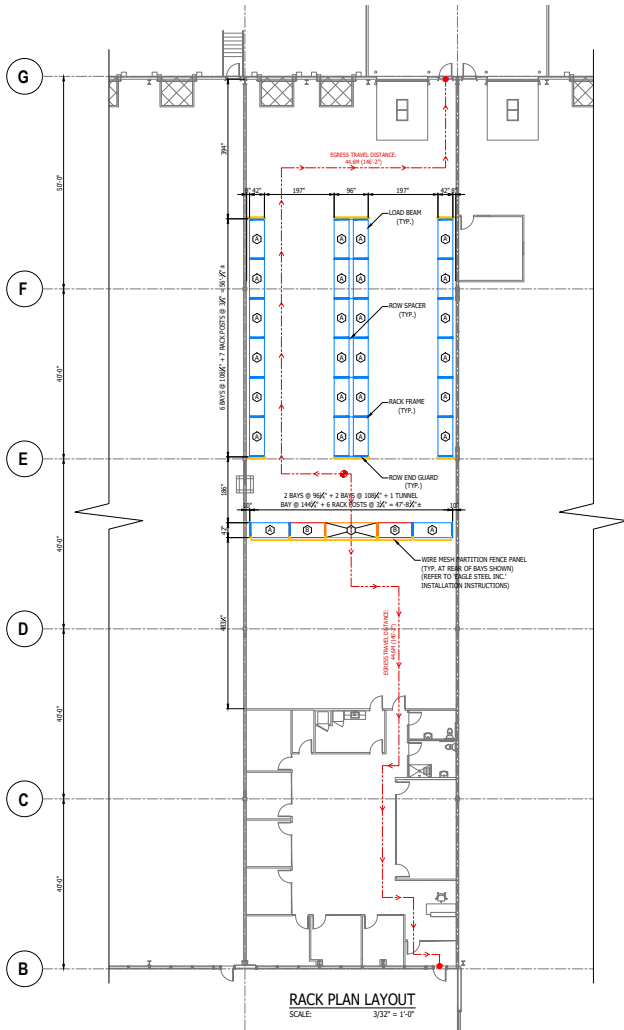

**SITE PLAN**

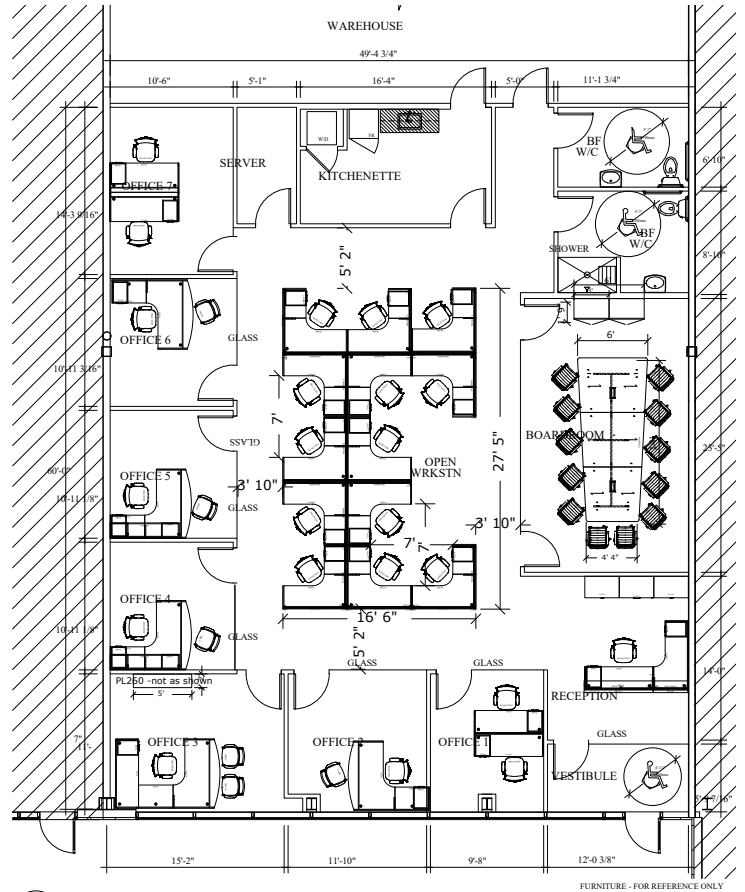
**BUILDING 1**  
7350 110TH AVE SE

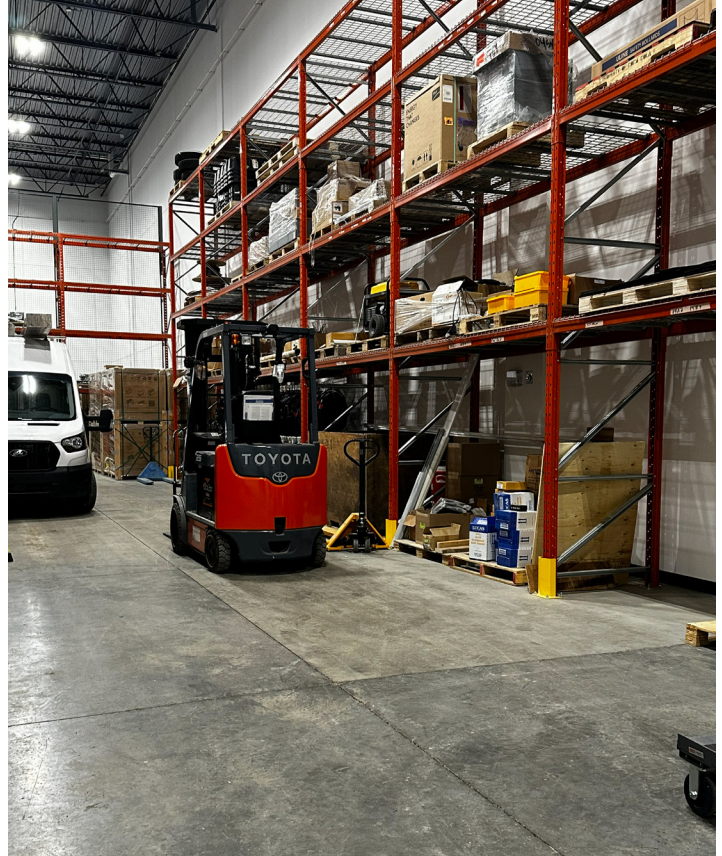


**RACK PLAN LAYOUT**

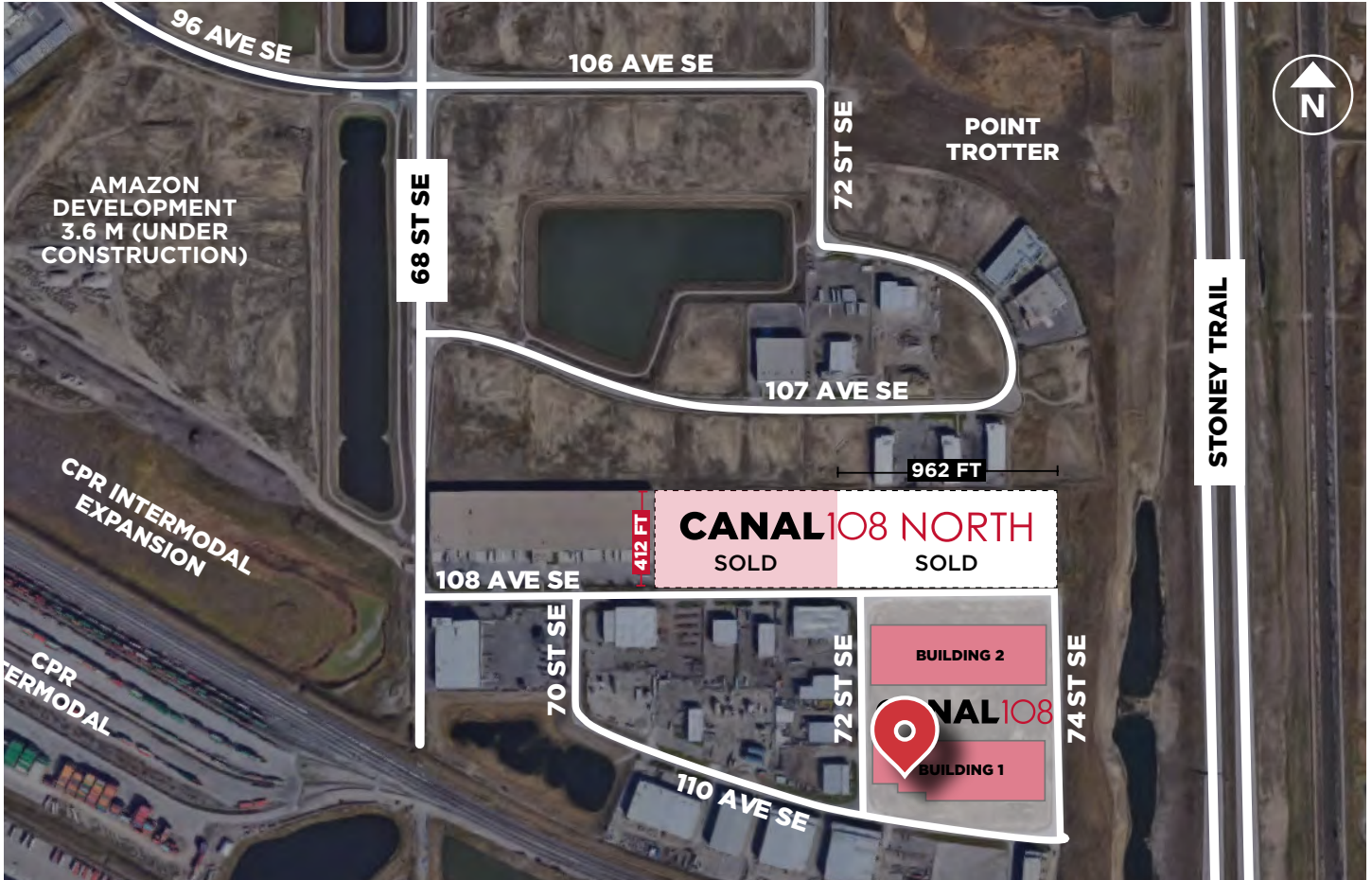


**OFFICE SPACE LAYOUT**
