Avison Young has been retained by Bricks Damiani Inc., in its capacity as Court-appointed Receiver, to advise on and manage the sale of 353 St Paul Ave, Brantford, Ontario (the "Property"). This offering presents investors or owner-users to acquire a 16,690 sf, two-storey medical office building on a 1.38 acre site. The Property is currently 5.7% occupied by a single tenant and includes ~ 95 surface parking spaces.

The Property is situated within 350 metres of Brantford General Hospital, a 299-bed acute care facility, which makes the Property an ideal location for a medical-office-clinic location, as it is in the core of the city's established medical corridor.

The City of Brantford provides its residents with excellent connectivity with various modes of transportation including its own transit system, multiple highways, passenger and freight railway service on CN's Quebec-Toronto-Windsor line, GO Bus service connecting to Hamilton and the GTA, and the Brantford Municipal Airport connecting residents to both national and international markets.

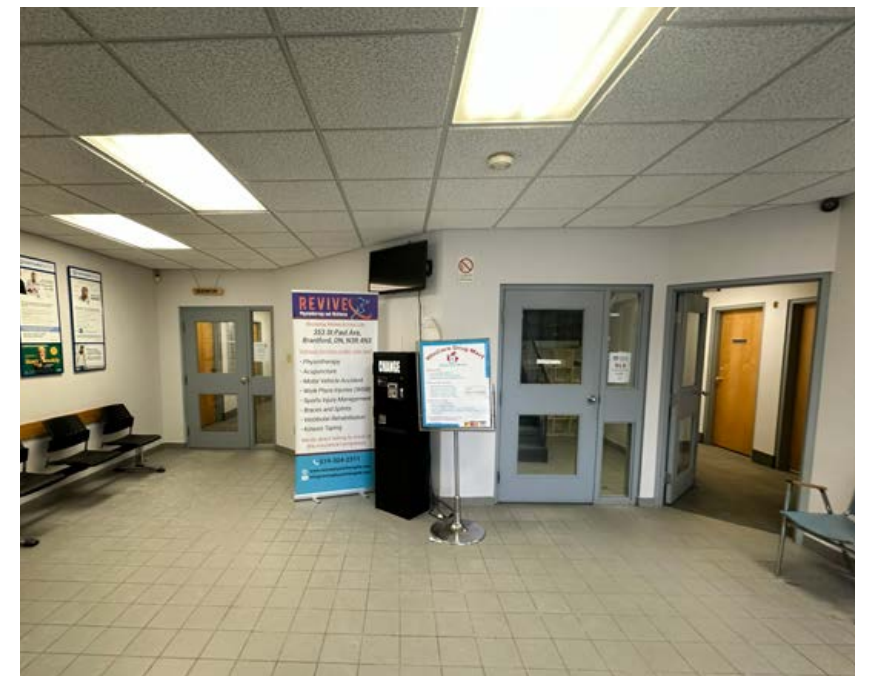
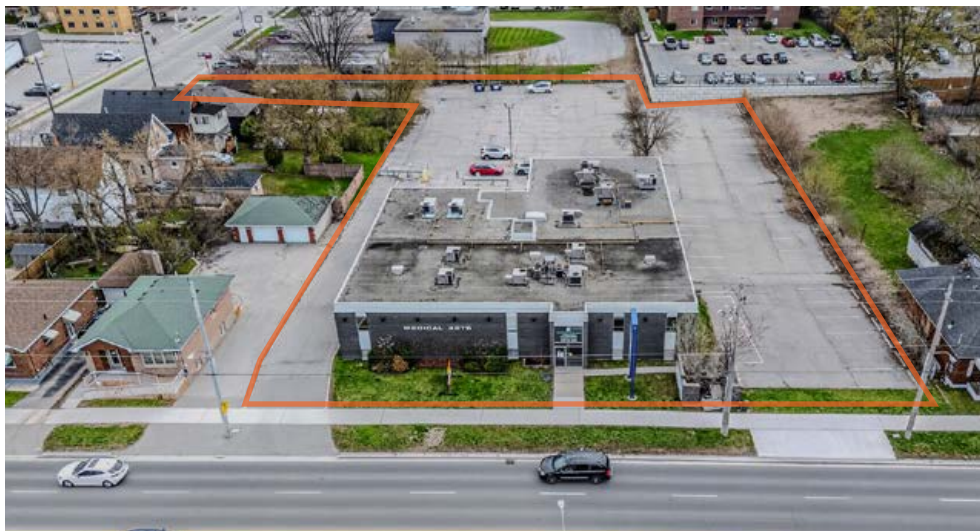
