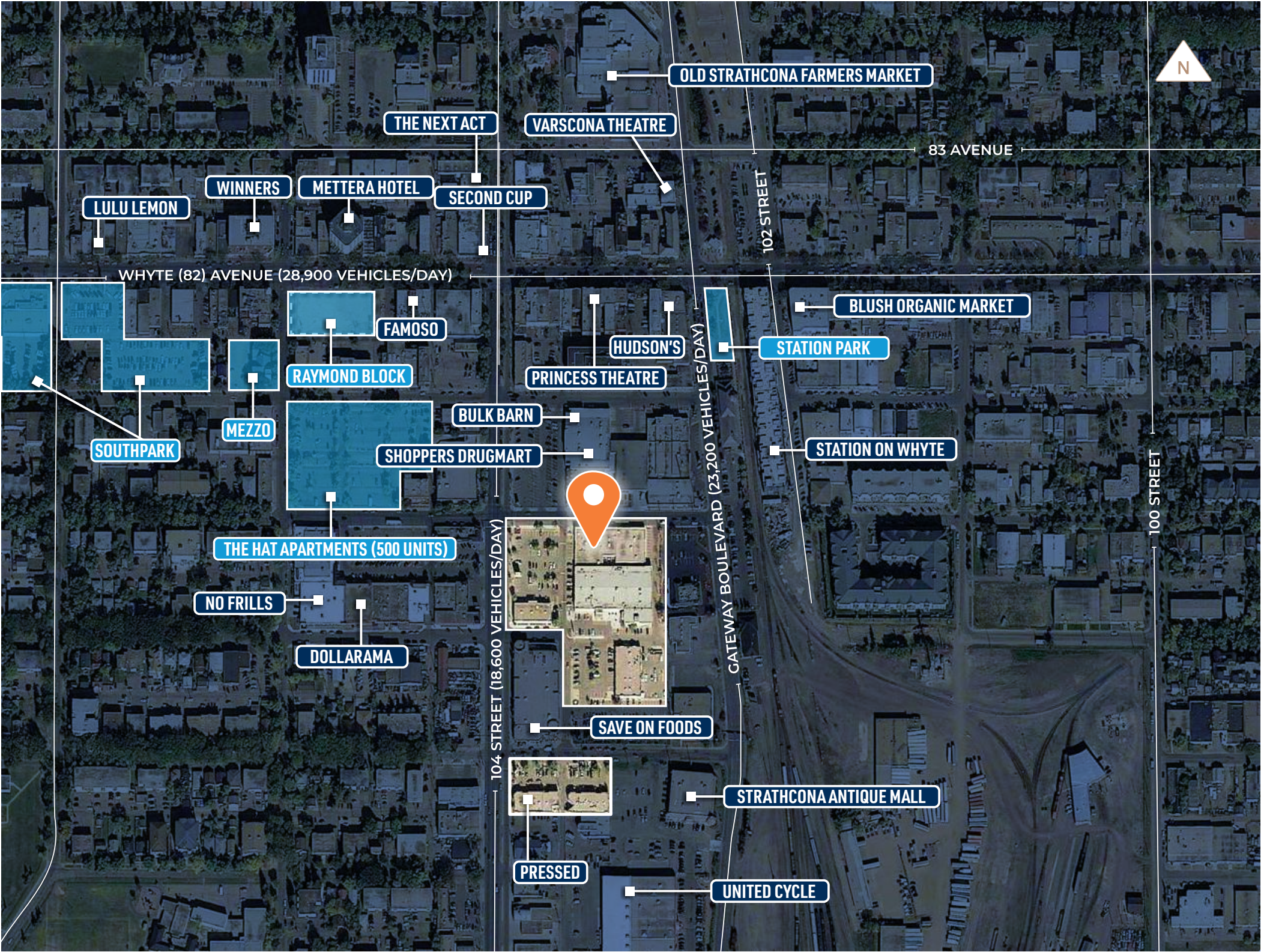
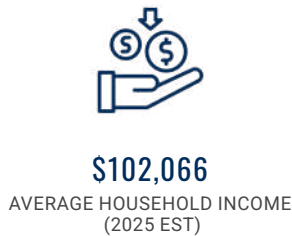
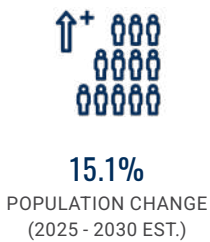
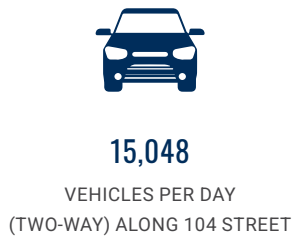
SITE PLAN / STRATHCONA TOWN CENTRE
